I understand that it shall be unlawful for any peddler, canvasser, solicitor, or transient merchant as defined by Bonners Ferry City Ordinance, to engage in business within the corporate limits of the City of Bonners Ferry without first applying for any obtaining a license to do so. Any license issued shall not be transferable or valid after the end of time for which the license is granted.

Upon receipt of a completed application the City Clerk shall refer the application to the Chief of Police who shall cause an investigation to be conducted within a reasonable time to determine the validity and completeness of the information presented on this application. A license will not be issued without completion of an investigation and undertaking sales before such license is issued is punishable as a misdemeanor.

If the application is approved, the City Clerk shall issue a license. If the application is denied, the City Clerk shall provide written notification to the applicant in accordance with Bonners Ferry City Ordinance.

BY SUBMITTING THIS APPLICATION, I HEREBY AUTHORIZE THE CHIEF OF POLICE OR HIS DESIGNATED AGENT TO CONDUCT AN INVESTIGATION TO DETERMINE THE VALIDITY AND COMPLETENESS OF THE INFORMATION I HAVE PRESENTED ON THIS APPLICATION, INCLUDING, BUT NOT LIMITED TO, A CRIMINAL HISTORY BACKGROUND CHECK THROUGH LOCAL, STATE, OR NATIONAL LAW ENFORCEMENT AGENCIES.
