The regularly scheduled council meeting of July 3, 2007 was called to order at 7:00 p.m. by Mayor Darrell Kerby. Present for the meeting were Mayor Kerby, Council President Russell Docherty, Council Members John Langs, Mick Mellett, and Dave Gray, Deputy Clerk Tamera Stemmene, City Administrator Stephen Boorman, Fire Chief Larry Owsley, City Attorney Tim Wilson. The consent agenda contained the following: roll call; approval of July 3, 2007 accounts payable; approval of June 19, 2007 Council meeting minutes; approval for Sewer department to attend Troubleshooting Lagoon Systems on July 24, 2007 in Bonners Ferry.

Mayor Kerby read a letter from the Hagadone Hospitality Company stating that the Visitor's Center was a good thing. Enclosed was a check donated to the center for \$1,000.00

Russell Docherty moved to authorize the Mayor to sign Contract Amendment #3 with Panhandle Area Council for the Water Tank Project. Mick Mellett seconded it. The motion passed- Mick Mellett "yes", Russ Docherty "yes", John Langs "yes", Dave Gray "yes"

Stephen Boorman recommended to Council to approve Change Order for Visitor's Center and said with the additional rock and asphalt it will be a better project. John Langs moved to approve Change Order #2 for the Visitor's Center Project. Dave Gray seconded the motion and it passed - Mick Mellett "yes", Russ Docherty "yes", John Langs "yes", Dave Gray "yes".

John Langs moved to authorize the Mayor to sign the agreement with Boundary County for the

The Council discussed the update on Riley Creek property. Mayor Kerby stated that we had our consultant meet with their consultant.
