City Council President Russ Docherty called the special meeting of September 28, 2007 to order at 8:20 a.m. Present for the meeting were Council President Russ Docherty, Council Members Mick Mellett and Dave Gray, and Clerk Kris Larson. Also present was Elaine Sandman from the Bonners Ferry Herald. Council President Russ Docherty turned the meeting over to Councilman Mellett to administer.

Mick Mellett opened the hearing and recessed it at 8:21 a.m. The hearing reconvened at 8:25 a.m. There was no public comment. Mayor Kerby joined the meeting at 8:26 a.m. Russ Docherty moved to close the hearing since there was no comment. Mick seconded the motion and it passed, all in favor.

Mayor Kerby took over administration of the meeting.

Russ Docherty moved to amend the fiscal year 2007 budget. Mick Mellett seconded the motion. The motion passed, all in favor.

Dave Gray moved to have the first reading of Ordinance 506 Amending Ordinance 500, the Appropriation Ordinance for Fiscal Year 2007. Russ Docherty seconded the motion and it passed, all in favor. Clerk Kris Larson read Ordinance 506 in its entirety.

Mick Mellett moved to have Ordinance 506 read by title only twice. Dave Gray seconded the motion and it passed. Clerk Larson read Ordinance 506 twice by title only.

Russ Docherty moved to adopt ordinance 506. Mick Mellett seconded the motion. The motion passed – Russ Docherty "yes", Mick Mellett "yes", Dave Gray "yes". Ordinance 506 reads as follows:

## BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF BONNERS FERRY, IDAHO:

Section 1: That Ordinance 500, the appropriation ordinance for the City of Bonners Ferry, Idaho for the fiscal year commencing October 1, 2006 and ending September 30, 2007 be and the same is hereby amended. The following sums are hereby appropriated:
