Glenda Poston moved to approve the minutes for March 21, 2019. Sue Larson seconded the motion. The motion passed with all in favor.

OLD BUSINESS

2. Urban Agriculture/Farming. DISCUSSION/ACTION: Direction to staff regarding draft amendment

Clare distributed a revised draft of the ordinance and provided background on the ordinance amendment for agriculture uses for A and AA zones for new Commissioner Morgan.

Discussion regarding the second draft of the Urban Agriculture/Farming Ordinance as follows:

Added new garden and community garden definition. Added the use of waste houses/containers regarding issue of manure. Updated uses table listing to remove need for permitting. Created a separate line on the Uses table for community gardens to eliminate confusion on animal standards and compost/manure applications to gardens.

Discussion of male goats. It was decided that male goats must be castrated to prevent aggressive behavior and odor. Omit "horn" requirement as in some breeds of goats both males and females have horns – becomes breed specific.

It was decided that intact (uncastrated) males of species will not be allowed within city limits (roosters, rams, bulls, stallions).

Revised 11-2-1(C)(1)(f), to read "Other animals: Type and maximum numbers recommended by Planning and Zoning, set by City Council."

The maximum number of goats, horses, cattle, chicken, and beehives was discussed.

Claire will email all of the draft versions of the Urban Agriculture/Farming Ordinance to the Planning and Zoning members.
