Police Chief said Mallorie Stippich finished her FTO on March 30 and is on her own now.

City Engineer Mike Klaus said he requested that American Rescue Plan Act is discussed at the Association of Idaho Cities meeting. The under drain for Filter #1 will be completed this week. Adam asked about the alternative routes for Fry Street sewer main. Mike said he is still working on the best route. Mike spoke with ITD today regarding the pole moves for the next phase of the highway project. Mayor Staples asked about the Riverside project. Mike said the Electric department is working on the Riverside project when they have time.

Economic Development Coordinator Dennis Weed said SBA grants are available for restaurants. Chad Case's marketing video will be out soon.

4. Police - Discuss repairing or replacing the 2013 Chevy Tahoe {action item}

Mayor Staples asked Jimmy to give his opinions on the Tahoe. Jimmy said replacing the transmission will cost approximately \$4,000. Mayor Staples asked how many miles are on the Tahoe. Jimmy said 160,000. Brian said there is a 2016 All-Wheel Drive Charger available for \$8,000 with approximately 120,000 miles. Adam asked if the Tahoe is worth \$4,000. Jimmy said maybe. Brian said we have two other Tahoes that we can possibly use to make one whole Tahoe. Ron asked if it was budgeted. Brian said no. Rick said we will be money ahead to invest \$8,000 in a different vehicle. Rick Alonzo moved to use \$8,000 from contingency to purchase a 2016 Dodge Charger from Idaho State Police. Ron Smith seconded the motion. The motion passed. Adam Arthur – yes, Valerie Thompson – yes, Rick Alonzo – yes, Ron Smith – yes

5. Golf - Discuss repairing or replacing the 2013 John Deere fairway mower (attachment) {action item}

Jimmy said this mower has an excessive amount of internal damage. Rick asked if the frame is any good. Jimmy said possibly. Ralph said the mower is not working as expected. He received a quote from Toro for \$20,000 for a used heavy-duty mower. Ralph asked if Julie could purchase the Toro in lieu of rent. Andrakay said she will have to think about that. Mayor Staples said option one \$16,000 to repair. Lease option \$376.93 per month. Adam asked if there is a lease option for the used mower. Ralph said yes. Adam asked if there is a warranty on the used mower. Ralph said no. Adam asked if there is any money left of the \$4,000. Jimmy said about \$1,600. Valerie Thompson moved to replace the fairway mower 60 month 376.93 per month contingent upon review of the lease documents and possibly accepting this in lieu of rent by the golf course manager. Ron asked if this is the best way to go. Jimmy said since the money is so close, replacing it is probably the best way to go. Valerie withdrew her motion and requested more information and have a special meeting when more information is available. Ron asked if it is possible to borrow the money from the Electric Department. Andrakay said in theory it is possible.

6. **Water** – Discuss replacing the transmission for the 1989 Kenworth dump truck (attachment) {action item} Jimmy found a used, inspected transmission for \$4,500. Valerie asked if it is worth putting the money into this dump truck. Jimmy said it is. Adam Arthur moved to replace the transmission in the 1989 Kenworth dump truck for a total cost of \$5,000. Valerie Thompson seconded the motion. The motion passed. Adam Arthur – yes, Valerie Thompson – yes, Rick Alonzo – yes, Ron Smith – yes

7. City – Discuss the budget hearing date (attachment) {action item}

Mike said we entered a contract with FCS earlier this year. The main reasons for this are: BPA is increasing the City's transmission rates by 16%, ongoing financial obligations and capital plan requirements. Adam asked about the rate study prior to the bond. Mike said this will be a fine-tuned look at each rate class. Rick asked about the optional report. Mike recommends the basic study at this time. Valerie Thompson moved to authorize the Mayor to sign the task order from the FCS Group for the Cost-of-Service Update in the amount of \$29,770.00. Rick Alonzo seconded the motion. Ron Smith moved to reduce the number of Planning & Zoning Commissioners from seven to five. Rick Alonzo seconded the motion. The motion passed. 11. **Planning & Zoning** – Discuss the Blue Cross Foundation grant for the Comprehensive Plan re-write (attachment) {action item} Lisa said there is State mandate to plan for 17 sections in the Local Land Use Planning Act. Blue Cross is offering a grant up to \$50,000 to help re-write the Comprehensive Plan. Mayor Staples asked if the \$50,000 is to used for the RFQs. Lisa said the foundation is willing to help with the RFQ process to ensure the City has met the foundation's expectations. Valerie Thompson moved to pursue the Blue Cross Foundation grant for the Comprehensive Plan re-write. Adam Arthur seconded the motion. The motion passed. 12. **City** – Discuss administration services for the Urban Renewal Agency (attachment) {action item} Mayor Staples said Panhandle Area Council has stopped managing the URA. Ron asked why PAC is stepping away from managing. Dennis said PAC is losing money by managing the URA. Lisa said she is willing to do the administration side, not the accounting. Rick Alonzo moved to take over the administration side for \$500 per month. Adam Arthur seconded the motion. The motion passed.
