



The City has been working with Schweitzer Engineering Laboratories (SEL) to complete the controls upgrade. Last year the project was delayed because of a cracked runner that took several months to replace, complicating the project significantly. Recently, SEL was needed on site to help commission Unit 1 in coordination with Riverside Inc., our mechanical contractor, as both were needed to complete the start-up. The attached change order request describes the time and work involved by SEL.

Staff requests that the Council approve the proposed Change Order #5 by Schweitzer Engineering Laboratories for \$17,700 for Unit #1 commissioning, testing and start-up assistance.

RE:	Streets – Proposed Water Truck Purchase

In 2023, City staff put together a capital plan with respect to the Local Option Tax. One of the items on the list was a new water truck to replace an aging vehicle in the street department. The current water truck is used every week from spring until late fall each year to clean the streets downtown. The truck is also used to complete cleaning activities throughout the City.

The City mechanic and street department head have both sought out a newer truck, and have found one in Spokane. Both of those employees have driven the vehicle that is shown in the following pictures and recommend the purchase of the water truck with the specs shown. The City budgeted \$150,700 for the purchase of a newer water truck that would be used primarily by the street department, but will also have some use by the fire department. The proposed

RE:	Police – New Car Purchase

The police department has worked hard to find and purchase used vehicles because of the lower price compared to new. City staff is hoping to replace aging police vehicles with a new police car each year. Right now the department needs another vehicle as soon as possible, but the lead time on a new vehicle is lengthy. While staff recognizes an immediate need for a vehicle, there is also a need to order a new vehicle that would arrive in FY2025, that would rotate the next oldest vehicle out of use.

Staff proposes to purchase a new police vehicle each year as a planned capital expense with Local Option Tax money. Since the purchase and arrival of a new vehicle takes such a long time, staff recommends authorizing ordering this vehicle now so that it will arrive in FY2025.

The police department has received the attached option list for a new vehicle. The base price of the vehicle shown is \$46,400, and with the selected options comes to \$52,895. Staff requests that the Council approve the purchase of this vehicle up to \$60,000, knowing that some decals and additional equipment may be required once the car arrives.

While City staff recommends purchasing new police vehicles moving forward, we are currently in a position where the purchase of a used vehicle is needed. The Chief's current car is a 2016 Dodge Charger with over 175,000 miles on it. The department has located a used vehicle that has approximately 40,000 miles on it, with a purchase price of \$28,000. While this particular vehicle may not be available at the time of potential approval, other vehicles are available at a similar price and mileage.

Staff is requesting that the Council approve the purchase of a used vehicle up to \$30,000, with \$25,000 coming from Local Option Tax funds, and the remaining \$5,000 coming from remaining ARPA funds that are allocated to the police department.

RANGE: \$9-11 Depending on certifications held

STATUS: Part-Time, Seasonal SUPERVISOR: Pool Manager / Head Lifeguard

GENERAL STATEMENT OF DUTIES:

Maintains safe swimming conditions in the pool, on the deck, and surrounding areas. Creates a safe and positive atmosphere that promotes public safety and engagement.

DISTINGUISHING CHARACTERISTICS OF CLASS:

The incumbent of this class is responsible for safety and education of the public users of the City's municipal swimming pool. Incumbent receives general instruction from the Head Lifeguard or Pool Manager.

EXAMPLES OF DUTIES:

Maintains staff and patron safety, order, and discipline at the assigned aquatics facility. Performs emergency water-rescue techniques to assist persons in distress, applies CPR, and administers standard first aid when necessary. Assists in the implementation of aquatics programs and special events. Explains and interprets operational and programmatic rules and regulations to pool patrons; enforces or refers enforcement to proper authorities. Ensures general safety, cleanliness, and appearance of pool areas, restrooms, and showers when able to do so without distraction from lifeguarding responsibilities. Performs related work as required.

- Maintains constant surveillance of the pool and the pool areas.
- Maintains current knowledge of all emergency procedures within pool and pool area.
- Responds to emergency situations immediately in accordance with City policies and procedures; provides timely and accurate reports and follow-ups.
- Knows, understands, and consistently applies health and safety rules, policies, guidelines for the pool and pool area.
- Conveys information on programs and schedules.
- Maintains accurate records required by the City and state agencies.
- Performs equipment checks and ensures availability of required equipment.

REQUIRED SKILLS, KNOWLEDGE AND ABILITIES:

Knowledge of approved water-rescue and accident-prevention techniques, emergency procedures, simulation drills, water-safety policies, first aid, and CPR. Knowledge of water-safety practices and procedures. Some knowledge of operational safety and maintenance requirements for aquatics facilities.

Ability to react efficiently and effectively in emergency rescue situations.

Ability to perform assigned tasks requiring physical strength and agility.

Ability to react efficiently and tactfully with the public and to be capable of enforcing regulations firmly and impartially.

Ability to serve the public and fellow employees with honesty and integrity.

Ability to establish and maintain effective working relationships with the general public, coworkers, elected and appointed officials, and members of diverse cultural and linguistic backgrounds regardless of race, religion, age, sex, disability, political affiliation or sexual orientation.

Skilled in pool water rescue, accident prevention techniques, and water-safety procedures.

American Red Cross Lifeguard certification, First Aid and CPR certifications.

Water Safety Instructor certification is desired.

PHYSICAL REQUIREMENTS:

Ability to swim and perform in-water rescue. Ability to react to emergency situations by quick movements, strenuous activity, and on occasion assist or lift persons in distress of varying weights. Required to remain alert to dangerous situations while sitting, standing, or walking for various lengths of time. Ability to communicate verbally across distances in a noisy environment.

ACCEPTABLE EDUCATION AND EXPERIENCE:

Must be 15 and able to pass and receive the Red Cross Lifeguard Certificate.

SEASONAL COMMITMENT: Must be able to work from June through September, as pool season allows.
